Upper Blue Sanitation District (Owner) is requesting Bids for the construction of the following Project:

Iowa Hill Water Reclamation Facility (IHWRF) Integrated Fixed-Film Activated Sludge (IFAS)
Project

Bids for the construction of the Project will be received at the District's office located at 1605 Airport Road, Breckenridge, CO 80424 **until 2:00 p.m. on March 13, 2024**, at which time all bids that have been duly received will be opened publicly.

Description of Work

The work includes, but is not necessarily limited to furnishing of labor, materials, and equipment for the conversion of the existing IHWRF from a conventional activated sludge process to IFAS and will involve installation of an influent fine screen, aeration piping, valves, concrete placement, blower replacement, IFAS media installation, equipment installation, and site work.

The Project has an expected duration of 610 days.

Procurement Contracts to be Assigned to Contractor

Owner as "Buyer" has executed a procurement contract with Veolia WTS Systems USA, Inc as "Seller" for the procurement of goods and special services for the IHWRF IFAS Project and also with Hydro-Dyne Engineering, Inc as "Seller" for the procurement of goods and special services for the IHWRF IFAS Project. The materials and equipment to be provided through the procurement contract are to be furnished and delivered to the Site for installation by Contractor. Owner will assign said procurement contract to Contractor as set forth in the Agreement. Contractor will accept the assignment, as Buyer (Contractor/Assignee), and will be responsible to Owner for the performance of obligations by Seller, which will become a Subcontractor or Supplier to Contractor.

The contract documents for the procurement of goods and special services are included in the Bidding Documents for reference.

Registered plan holders will be provided with addenda, lists of registered plan holders, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated contact. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated contact.

Electronic only. Paper bidding documents will not be issued.

Pre-bid Conference

A **mandatory pre-bid conference** for the Project will be held on **February 22, 2024** at the District's office, 1605 Airport Road, Breckenridge, CO 80424. All prospective bidders are required to attend the pre-bid conference. Bids will not be accepted from Bidders that do not attend the mandatory pre-bid conference.

The project site will be available for review and inspection immediately following the pre-bid conference. The Engineer may issue addenda as the Engineer considers necessary in response to the questions raised in the pre-bid conference.

Questions, Interpretations and Addenda

Owner on its own initiative may issue Addenda to clarify, correct, supplement, or change the Bidding Documents.
