Creating a New Position and Operator Pay Scale. The board approved the Manager to make a new position and appropriate pay scale.

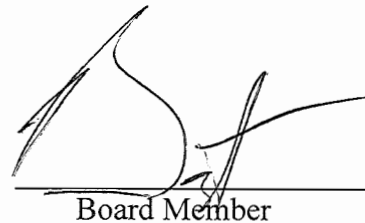
X. CORRESPONDENCE:
